

## PREFACE

This report summarizes data on adult felony sentences in Washington State for the period of July 1, 2000 through June 30, 2001 (FY2001). There were 25,248 felony sentences imposed in FY2001, representing a zero point nine percent increase from the number of sentences imposed in FY2000.

The sentences summarized in this report were imposed for crimes committed on or after July 1, 1984. Adults who committed felonies after that date were sentenced under the Sentencing Reform Act (SRA) of 1981, as amended, Chapter 9.94A RCW.

Under the SRA, every felony offense falls within a standard (presumptive) sentence range which is determined by reference to the seriousness of the current offense, coupled with the number and type of the offender's prior and other current offenses. In most cases, an offender will receive a sentence within the standard range for that offense. In four percent of felony cases, offenders are given "exceptional" sentences that fall outside the standard sentence range.

A sentencing judge may order an exceptional sentence outside the standard range if there are substantial and compelling reasons (either aggravating or mitigating factors) to do so. These reasons must be documented in writing. An exceptional sentence may be appealed by the defense or by the prosecution; standard range sentences may not be appealed. Occasionally, an exceptional sentence is imposed that does not result in confinement outside the standard range. Such a sentence may be used, for example, to require community supervision exceeding the standard range sentence, or to require treatment in situations where the standard sentence does not provide for it.

The length of confinement may be reduced up to one-third for good behavior, but may not be extended. Beginning with offenses committed on or after July 1, 1990, offenders convicted of serious violent offenses or Class A sex offenses may only receive an earned early release of up to 15 percent of the sentence. New offenses require new convictions before additional penalties may be imposed, although up to 60 days of jail may be ordered for violations of sentence conditions.

Alternatives to the standard range sentence are available for some eligible offenders. Nonviolent offenders who have no prior felony convictions and who are not being sentenced for a sex offense or certain drug offenses may have the standard sentence waived. This alternative, called the First-time Offender Waiver (FTOW), allows the sentencing judge to impose up to 90 days in jail, two years of community supervision and several conditions, such as maintaining employment or receiving treatment.

Sex offenders who have no prior felony sex convictions may receive a sentence under the Special Sex Offender Sentencing Alternative (SSOSA) if they are not convicted of a serious violent offense with a sexual motivation finding or of Rape 1, Attempted Rape 1 or Rape 2, and have a current offense and criminal history that permits the court to impose a sentence within the standard range of less than eleven years confinement. A person sentenced under SSOSA receives a suspended sentence within the standard range, a jail term of up to six months, and several conditions of sentence that may include inpatient and/or outpatient treatment. For offenses committed after June

30, 1990, SSOSA offenders receive three years of community custody or up to the length of the suspended sentence, if that is over three years.

The Drug Offender Sentencing Alternative (DOSA) allows for a reduction in confinement time for eligible offenders, combined with intensive treatment while in confinement and also during supervision in the community. Offenders sentenced on or after April 19, 1995, are eligible for DOSA. Effective July 25, 1999, the eligibility for DOSA expanded. The new eligibility rules include: the offense of conviction must be a non-violent, non-sex offense, the offense must not have a weapon enhancement, and the offender may not have any other current or prior convictions for a violent or sex offense. In addition, if the current offense constitutes a violation under the Uniform Controlled Substance Act, the judge must determine the offense involved a small quantity of the controlled substance. See RCW 9.94A.660. A court electing the DOSA option imposes a sentence of one-half of the midpoint of the presumptive standard range for the offense, to be served in a prison facility. The remainder of the midpoint of the standard range is served as a term of community custody, which must include substance abuse treatment, crime-related prohibitions and testing and monitoring for drug use.

## EXECUTIVE SUMMARY<sup>1</sup>

- In FY01, the total number of felony sentences imposed in Washington increased 0.9%, rising from 25,034 sentences in FY00 to 25,248 sentences in FY01.
- Significant changes in all sentences imposed in FY 01 are summarized as follows:
  - 6.3 % Robbery (from 630 to 590)                      + 2.0 % Property (from 8,557 to 8,730)
  - + 26.9 % Murder (from 108 to 137)                    – 0.2 % Drugs (from 8,689 to 8,675)
  - + 3.3 % Manslaughter (from 90 to 93)                + 12.7 % Sex (from 1,045 to 1,178)
  - + 0.3 % Assault (from 3,486 to 3,497)              – 3.3% Other (from 2,429 to 2,348)
- In FY01, 14 offenders were sentenced to life in prison as persistent offenders under the “three strikes” provision of Initiative 593. Nine sex offenders were sentenced to life in prison in FY01 under the “two-strike” provision of Initiative 593. The 23 new persistent offender sentences imposed in FY01 resulted in a decrease of 46.5% from the 43 sentences in FY00.
- In FY01, 30.8% of all sentences resulted in a prison sentence, a slight increase from 29.0% in FY00.
- The average sentence length increased from 13.6 months in FY00 to 14.4 months in FY01. The average prison sentence was 40.4 months in FY00 which increased to 40.5 months in FY01, while average non-prison sentence length remained stable at an average of 2.8 months.
- In FY01, the number of sentences imposed for Violations of the Uniform Controlled Substances Act (VUCSA) decreased by 0.2% over VUCSA sentences in the previous year. The number of sentences for “dealing” offenses increased by 1.4% and the number of sentences for “non-dealing” offenses decreased by 1.1%.
- The number of First-time Offender Waivers (FTOW) granted decreased from 2,445 in FY00 to 1,736 in FY01, a 29.0% decrease. Approximately 39% of the FTOW sentences were below the standard range minimum, while the remainder included sentences within or above the standard range.
- The number of offenders receiving a Special Sex Offender Sentencing Alternative (SSOSA) decreased from 231 in FY00 to 188 in FY01, an 18.6% decrease.
- The number of offenders receiving a Drug Offender Sentencing Alternative (DOSA) increased from 895 sentences in FY00 to 1,800 in FY01, an increase of 101.1%. These are all non-exceptional sentences.

Under current law, offenders sentenced under this alternative receive a suspended sentence and may receive up to six months in jail, community supervision for three years or the length of the suspended sentence (whichever is greater), inpatient or outpatient sex offender treatment, crime-related prohibitions and requirements for affirmative conduct. If the offender violates the conditions of supervision, the original suspended sentence may be imposed.

\*\*\*Offenders are eligible for the First-time Offender Waiver if the current offense is not a violent offense, sex offense or certain drug offenses, and if the offender has no prior felony convictions. If the First-time Offender Waiver is used, the standard range is waived and the offender may receive up to 90 days in jail, two years of community supervision, crime-related prohibitions and requirements for affirmative conduct. An aggravated departure occurs when an offender with a 0 to 60-day standard range (a Seriousness Level I offense with an offender score of 0) receives a sentence over 60 days (up to 90 days).

\*\*\*\*The Standard Range category includes some sentence departures not resulting from the use of the First-time Offender Waiver, SSOSA or an exceptional sentence. These departures often occur as the result of clerical errors.
